"IGT ICE 2025 CATCH THAT LIZARD PRIZE DRAW"

**TERMS AND CONDITIONS** 



#### 1. Promoter

1.1 IGT-UK Gaming Limited (the "**Promoter**") is launching the Catch the Lizard! promotion ("the **Promotion**"). The Promoter's address is Floor 2, 1 Exchange Quay, Salford, England, M5 3EA, and their contact email address is <u>esther.camarenseva@igt.com</u>. Any questions or concerns regarding this Promotion should be directed to the Promoter at the contact information provided.

### 2. Promotion Period

- 2.1 The Promotion will run from 00:00 CET on the 13<sup>th</sup> January 2025 to 20:00 CET on the 17<sup>th</sup> January 2025 ("**Promotion Period**"). All entries received outside of this Promotion Period will not be valid.
- 2.2 The Promoter accepts no responsibility for entries not successfully completed due to a technical fault of any kind.

### 3. Eligibility and Entry

- 3.1 The Promotion is open to:
  - (a) all persons aged 18 years or over.

# These are the "Participants".

- 3.2 Employees of the Promoter, their families, agents or any third party directly associated with administration of the Promotion are not eligible to participate.
- 3.3 Employees, contractors, directors and officers of any company engaged in the business of supplying and manufacturing gaming machines, systems, lottery products, game content and/or similar business activities of the Promoter or any affiliate are not eligible to participate or win.
- 3.4 Participants shall be required to provide a valid email address that the Promoter can contact them through.
- 3.5 Participants will search for five (5) concealed lizards on the Promotor's ICE 2025 promotion page <a href="https://www.igt.com/ICE">https://www.igt.com/ICE</a>, these will be hidden within IGT Game Titles. Once Participants locate a lizard, they must click on it, which will take them to the prize wheel and they will receive one (1) Prize Draw entry. The Promotion is free to enter, and no purchase is necessary.
- 3.6 The Promotion will run as follows:



- (a) Participants shall be required to locate hidden lizards on the Promotor's ICE 2025 promotion page, these will be hidden in IGT Game Titles. There will be a total of five (5) hidden lizards.
- (b) Participants, once they have located one (1) lizard, can click on this Lizard. Each Lizard can be clicked once. This process will be the same for all five (5) lizards, and Participants can search and locate all five (5).
- (c) Participants will then be directly to a pop-up page provided by Easypromos, in which a Prize wheel will be shown. Participants, once they have entered correctly their name and email, they will be eligible to spin the prize wheel. The Wheel Spin will result in the following Prizes, being randomly allocated:
  - (i) A €50 gift card set out in Clause [X]; or
  - (ii) A Mystery Prize set out in Clause [X]; or
  - (iii) An additional entry into the Prize Draw.
- (d) Participants will be able to spin the wheel a maximum of five (5) times, once per lizard found.
- (e) Participants will automatically receive one (1) Prize Draw entry for their participation. Additionally, Participants may gain additional Prize Draw entries through the Wheel Spin as specified in Clause 3.6(c)(iii).
- (f) To qualify, Participants must accurately follow the steps set out in Clause 3.6(c).
- (g) The Promoter will give 2 clues to assist Participants in guessing the location of the Lizards from 13 January 2025 till 17 January 2025 (inclusive) on IGT Gaming EMEA LinkedIn (<a href="https://www.linkedin.com/igt-gaming-emea">www.linkedin.com/igt-gaming-emea</a>) and IGT Gaming EMEA Facebook (<a href="https://www.facebook.com/IGTGamingEMEA/">https://www.facebook.com/IGTGamingEMEA/</a>) (the "Social Media Channels").
- (h) The Promotor shall reveal the Winners of the Prize Draw on the Promoter's Social webpage https://www.igt.com/ICE ("Reveal Date"). The Winners shall also be informed via email.
- 3.7 All entries must be submitted by Participants via submitting an entry using the online form provided by Easypromos. If Participants register under different accounts and attempt to take part multiple times on one (1) lizard, they will be ineligible.
- 3.8 If Participants fail to comply with Clause 3.4 above, the Participant will be ineligible. The Promoter reserves the right to select an alternate winner from the remaining eligible entries.
- 3.9 The Promotion is not sponsored, endorsed, administered or associated in any way with Facebook/LinkedIn, so the Participants release Facebook/LinkedIn from all responsibility for any damages that may arise from it.



# 4. Prize Draw winner selection and prizes

- 4.1 On this Promotion, three (3) winners will be selected randomly using the Easypromos' random winner picker tool after 20:00 CET on the 17<sup>th</sup> January 2025 ("**Draw Date**"). Easypromos is a self-service online platform that guarantees the transparency and result of the sweepstakes and provides a certificate of validity for each one of the sweepstakes. The result of the winner selection using the random winner picker tool cannot be altered by the Promoter or Easypromos and can be shared with any Participant who requests it from the Promoter. The celebration of the sweepstakes, as well as the prize assignment and distribution, are subject to the current tax legislation.
- 4.2 The 3 winners will receive either:
  - (a) X1 Apple iPad Air 11" (2024) M2, Wi-Fi; or
  - (b) X1 Apple Watch SE GPS 40mm; or
  - (c) X1 Drone with camera DJI Mini 3 Fly More Combo with CR.

("Prize Draw Prizes").

- 4.3 The 3 winners will not have the option to choose their specific Prize Draw Prize. Prize allocation will be determined exclusively through the designated random winner picker tool set out in clause 4.1 above.
- 4.4 The 3 winners will be notified via email by IGT's designated employee. If a winner has provided a false email address/ fails to be contactable when the winner is announced and/or the winner fails to qualify for the Prize as detailed above then the winner's Prize will be forfeited and the Promoter will be entitled to select another winner in accordance with the process described above.
- 4.5 The Prize will be given to the winners on either the 20th 21st or 22nd January 2025 in the IGT booth at the ICE Barcelona Tradeshow during operational hours by IGT's designated employee or if elected by the winners the Prize will be sent by post within 28 days of being notified of their win. IGT will pay the postal expense of a basic Spain fare or international standard, any further postal options will be at the winner's expense. Whether shipped by IGT or at the winner's option, the winner is liable to pay for any import taxes including but not limited to import taxes.
- 4.6 If the winner is unable to collect from the IGT booth or prefers to not have it posted. They may nominate one (1) person to collect it on their behalf. The nominated individual will be required to present a valid form of identification upon collection. Acceptance of the nominated person is at IGT's discretion.
- 4.7 The Prize Draw Prizes for the winners is non-exchangeable, non-negotiable, non-transferable and no cash alternative is offered.



4.8 The Prize Draw Prizes is supplied by the Promoter. The Promoter reserves the right to replace the Prize with an alternative prize of equal or higher value if circumstances beyond the Promoter's control makes it necessary to do so.

## 5. Gift Card provided by GoGift

- 5.1 If Participants win a €50 gift card through the Prize Wheel spin, they will be provided with a voucher code, they will be directed to GoGift website (URL: <a href="www.gogift.com">www.gogift.com</a>) where they can redeem a Gift card through the voucher code ("Gift Card Winners").
- 5.2 Gift Card Winners will be required to provide their country of residence and based on this will be given different gift card options available in their country of residence.
- 5.3 The Gift Card is provided by GoGift a third-party Vendor, this company is not associated with the Promotor.
- 5.4 The Gift Card is non-exchangeable, non-transferable and no cash alternative is offered.
- 5.5 If the Gift Card Winner fails has provided a false email address or fails to qualify for the Prize as detailed above in clause 5.2, they will not be able to redeem the Gift Card, and the prize will be forfeited.

### 6. Mystery Prizes

- 6.1 The Mystery Prize will be one of the following items:
  - (a) IGT Backpack or
  - (b) IGT Water Bottle or
  - (c) IGT gloves or
  - (d) IGT Merchandise which will be chosen and allocated by an IGT representative.

("Mystery Prize").

- 6.2 The Mystery Prize is non-exchangeable, non-transferable and no cash alternative is offered.
- 6.3 The Mystery Prize is supplied by the Promotor. The Promotor reserves the right to substitute or modify the Mystery Prize at its sole discretion without prior notice, for a prize of equal or greater value. Any change will be communicated to Mystery Prize Winners as soon as possible.
- 6.4 Mystery Prize winners will receive a code via email, Mystery Prize winners are required to collect the Mystery Prize on either the 20<sup>th</sup>, 21<sup>st</sup> or 22<sup>nd</sup> January 2025 in the IGT booth at ICE Barcelona Tradeshow during operational hours from an IGT designated employee and will be required to show the code they received when collecting the Mystery Prize.



6.5 If Mystery Prize Winners fail to collect the Mystery Prize in accordance with clause 6.4, they will forfeit the Prize.

### 7. Limitations and Disqualification

- 7.1 The decision of the Promoter regarding any aspect of the Promotion is final and binding and no correspondence will be entered into about it.
- 7.2 Participants are deemed to have accepted and agreed to be bound by these terms and conditions upon entry. The Promoter reserves the right to refuse entry, or refuse to award the prize to anyone in breach of these terms and conditions.
- 7.3 The Promoter reserves the right to hold, void, cancel, suspend, or amend the Promotion where it becomes necessary to do so.
- 7.4 Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees. Your statutory rights are not affected.
- 7.5 Any tax or fiscal fee that may arise from the acceptance of the Prize will be the responsibility of the winner, as well as any other expense derived from the Promotion that has not been previously assumed by the Promotor in the Terms and Conditions

### 8. Data Protection & Publicity

However, the Promoter will only process personal data in accordance with applicable data protection laws, including obtaining any necessary consents and providing participants with any required notices or rights. Participants may have the right to request access to, rectification, or erasure of their personal data or to restrict or object to its processing. Any personal information collected from Participants in the Promotion will be used in accordance with the Promoter's privacy policy.



#### 9. Amendments

9.1 The Promotor reserve the right to modify or extend these promotional bases, to the extent that it does not harm or impair the rights of the Participants in the Promotion.

#### 10. Release and Indemnification

10.1 By entering the Promotion, Participants agree to release and hold harmless the sponsor, and each of its respective parents, subsidiaries, affiliates, advertising and promotion agencies, other companies associated with the Promotion Agencies, other companies associated with the Promotion, and each of their respective officers, directors, employees, shareholders, representatives, and agents (the "released parties") from and against any and all losses, damages, right, claims or causes of action of any kind arising in whole or in part, directly or indirectly from the Promotion, or resulting directly or indirectly from acceptance possession, use or misuse of the prize awarded in connection with the tournament including, without limitation, personal injury, death, and or property damage, as well as claims based on publicity rights, defamation, and/or invasion of privacy.

## 11. Governing Law

11.1 These terms and conditions and this Promotion are governed by English law. If any entrants to this Promotion wish to take court proceedings, then they must do this within the courts of England and Wales.
